Labour Management-Friel

-Management has agreed to ensure A/C's are marked as official on the dates they passed their process, not on the day they begin acting. This is to protect their seniority in the event of amalgamation.

-Day staff lieu day selections in regards to SOG 1402, management says they will only discuss at bargaining. All issues that surround picking lieu days for day staff will be deferred until then.

-Exposure forms; new ones on target solutions, new submit button sends it automatically.

-PFAS: management will be working with H&S committee on working through the issue.

-Job shadowing: management will support practice of suppression to shadow an FP position if a member wishes to do so, however, it must be on that member's own time and there will be no compensation for it.

-Daystaff shifting schedule: the association will no longer tolerate shifting schedules to avoid observing a holiday. For example, the recruits 4-day workweek being shifted forwards or backwards to miss a holiday, so they work full week hours even when the workweek contains a holiday. We warned management about this practice and will grieve it in the future if required.

Grievance Committee – Friel

-Education calendar: date cancelled by hickey, waiting for new date

-Accommodation Grievance: Scheduled for November

-Failure to grant lieu day (Queen's Funeral): Arbitration scheduled for November

-The association will be filing a grievance due to Benefits deficiencies witnessed since changing to Desjardins

-Automatic aid: Management wants Ajax to respond to west Whitby calls to avoid building a new hall. This violates contracting out language, and we will monitor and file a grievance if required.

-2 members requested to present to the negotiations committee, they will have time soon to do so.

Government Relations - Brandon, Friel

-Council meet and greet with the executive next week.

-Met with MPP Lorne Coe last week, upset we did not support him last election. We shared concerns about Bill 23.

-Bob and Friel will attend with the OPFFA and Premier on Monday for the announcement of a 1.6million dollar grant that will be put towards Ontario Firefighters. Details to follow the announcement.

-new exposure forms on target solutions, at the bottom of the form it says the town has no liability of the form. This disclaimer has been altered at associations request, saying the town has waived their right to view the form.

-Ted Varjas, Dylan Gallant, Dan Chalk, have now been trained to safety officer level one

-PFAS meeting coming up on Wednesday

Todd: Are my old exposure forms still relevant if they were submitted without the town's disclaimer?

Friel: Your old forms are likely to help build a case, they are still relevant for you to help build your argument in your favor. This new disclaimer strengthens the value of the new forms but does not invalidate the old ones.
