Labour Management—President Friel

- -Management has agreed to set AC positions as when they pass the tests, so their seniority is protected in the event of amalgamation.
- -PFAS: management set out best practices, but refuse to make an SOG
- -Clothing Trial: In June we agreed with management to begin a clothing trail. However, management refuses to submit a MOA, so the topic will likely move to negotiations if not resolved soon. Concern is that nomex uniforms contain harmful chemicals.

Grievance Committee - Friel

- -21-006 Still waiting for response.
- -Arbitration in October for a personal grievance. Waiting for their proposal
- -22-006 failure to grant lieu day, Queen's funeral day, Nov 8th arbitration date set
- -23-003, benefits grievance. Heard and denied at all stages. Looking for arbitration. Bio-similar language, generic drug issues.

- -Submissions received

Government Relations – Swail

- -Met with council in May for a meet and greet, only 2 councilors did not attend
- -pushed for 7th fire truck with council
- -their response was supportive

- -Bonin and Thomas attending legislative conference in November

Health and Safety – Chalk

- -uniform trial not going well due to management's refusal to co-operate
- -electronic exposure forms working well

Charitable Committee – Bowers

- -successful golf tournament, over \$11,000 raised for SickKids
- -Movember coming up soon, other locals pushing for "Durham Fire" so together we can raise more money collectively.

-committee been busy helping former firefighter/chief who passed. Application for memorial grant. Work in progress.

Memorial ad hoc committee

- -\$180,000 remaining to raise.
- -Committee has been created to help Vice President Girard raise the funds.

- -Honor guard attended Fallen Firefighter Memorial for Bob Vessey

- -This weekend Friel, Spencer, Gilchrist and Kennedy will attend Colorado Springs Fallen Firefighter Memorial for Bob Vessey
- -October OPFFA Health and Safety seminar upcoming. Girard, Vardjas, Gallant, Copeland attending

- -Patterson, Kelly, Canfield, Rob Currie have joined the peer support team.
- -New public education officer begins Tuesday
