#### **<u>Labour-Management:</u>** President Friel

- -Duty exchange LOU: We need to sign it, but it's pretty much done. You can now call in sick for a duty exchange. We will try to get an SOG for it from management. If you cannot report for it, you are supposed to call the PC and they will call the senior officer. Do not call dispatch.
- -Honor guard MOA: management team is not confident they can get budget for it. They will revisit it in 2025. We will rescind it if they don't do it by then.
- -FAF process, a reminder that if you are off for 3 shifts, management can ask for an FAF. It does not state in our CA you need it before returning to work. Only submit it when asked, after you return. If they want you to have one before you return to work, call the union.
- -AC/APC start dates. They are still working on it, planning on adding another column on the promotional schedule with it, to protect seniority in the event of amalgamation.
- -Promotional exam emergency meeting: concluded before this meeting was held.
- -Silo: partial silo this year, members have been contacted on who they are.
- -Training officers working OT: they proposed only working Saturday and Sunday, as FF or captains. We said no, it's a negotiations item.
- -Clothing trial: will conclude August 31, 2024. Surveys will be completed; management and union will discuss the results of the surveys.
- -West Whitby: management brought up the new truck as a day truck. We are not interested in a day truck, or that model. It does not align with the collective agreement.
