-Met with MP Turnbell to talk about federal grant next week. Another meeting on Tuesday with someone else for a grant. Looking to partner with brock street to sell a memorial beer.

## **Government Relations** – President Friel

-Whitby Budget released last week. A lot of gray area regarding hiring the 7<sup>th</sup> truck. Different interpretations on what it means. Chief making comments we are not getting it. He was under the impression from a senior staff member in the town it was not going to be hired in 2025. I called the mayor for clarification. The mayor is issuing a directive to make it clear we are getting it in 2025. Town staff drafted original budget, it is clear senior leadership have an issue with fire. They tried to implement staffing protocols that are not cleared by council. Mayor has assured us they will get hired in 2025.

Linton- Were we looking for closer to 30 hires?

Friel: 20 is for the 7<sup>th</sup> truck, everything else is for attrition. Chief has said the class might be 25 to account for attrition.

## Grievance Committee – President Friel

Benefits Grievance: Town has called it non arbitable. 3 days now being used to prove it is, instead of resolving the grievance, going to push it back until the end of Feb now.

-Sept 2025 for attendance grievance arbitration

-Sicktime calculation: doing their calculation to make everyone whole, they have until the end of the year to do this.

## New Business

Friel:

-I will provide overview of our election. The election period will be until the end of the month, at which time a ballot box will travel around to the halls via myself and the Stewards. The election committee will be myself and the stewards, I will be the chair. Those nominated must follow the rules outlined in our constitution regarding their election.

Gostlin- Any updates about the training officer position? Are all the candidates external?

Friel: -We did have internal candidates. Many external candidates are not qualified for the job. I would say they have less than 10 qualified candidates, with a couple internal candidates.

Thomas: I would like to present a Notice of motion: to increase canteen dues by \$1 for the purpose of increasing our fitness budget.

Friel: Ok, Secretary Anderson will note that and email a notice of motion for our December meeting.

-Sluman: payroll issues; are we satisfied with our pay or are we going to have an audit for our pay?

-Friel: we have had a meeting with HR and the stewards on their platoons. We have not had a full resolve on how it is going to be paid back. We have ongoing meetings.

-Sluman: Can we ask to have everyone's pay looked at?

Jon: We have an upcoming meeting with payroll to discuss it. Some of the issue, is that with temporary roles, some lines of communications are falling through, and resulting in incorrect pay. We are waiting for a date and a time to meet with them to try to resolve.

Sluman: I think we may need an audit to make sure people are getting paid properly. At what point to we say check everyone?

Friel: Yes, that's on the table and we will discuss.

Lee Williamson: Remembrance Day ceremony, we had 2 honour guard and 6 members in Brooklin. I would like to see if we could have money for honour guard for more ceremonial equipment, so if there are 2 events at the same time, the honour guard has things to carry if the guard is split.

Friel: I believe we had enough equipment, Kennedy do you want to speak to it?

Kennedy: We have 4 flags and 2 axes. We could look at some options but the quality of the current flag from the town is not good.

Friel: Kennedy do you see the need for new equipment?

Kennedy: we could always use more equipment, depending on financing.

Friel: Ok we will discuss on the executive and report back on the December meeting.

Gilchrist:

## Motion:

I move to have an adhoc committee struck with one member of the executive board, a steward, Mark Kennedy, and member at large to review the Honour guard LOU, Audit inventory we have now, cost that will be incurred in purchasing new equipment, and the possibility of alternative funding.

Gilchrist: I was part of the honour guard originally. The equipment we had was haphazard at the time.

Heron: Suggestion to reach out to the legion or other places for outside places of funding.

Friel: we will put out a notice for members looking to join the Adhoc committee.

Heron: I believe we should request a full audit for pay issues. The issues are constant, we have to remind them of things all the time. Paystubs should be all in plain language. It's also not right we don't have sicktime on our stubs.

Friel: We hear you guys loud and clear. When the town changes to workday software we will see if they can put in the new stubs. We will discuss the audit with HR when we meet with them shortly.

Heron: Weill we be required to put it in our phones?

Friel: We will need to wait and see how it works, but you will not need to put workday on your personal phone.
